**We provided emergency shelter and family support services to individuals and families that were either homeless or at risk of homelessness. 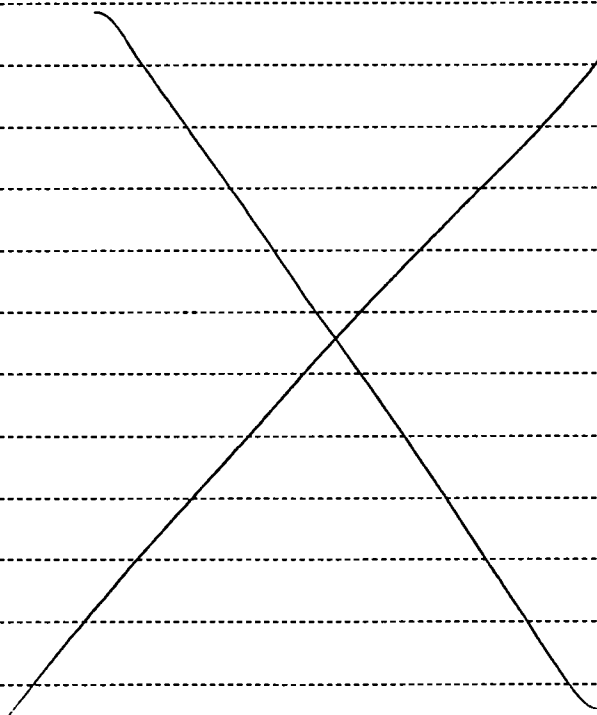
